To identify the electrical risks according to regulation RD 614/2001. To explain the effect of electricity on the human body. Types of contacts and preventive measures.

To list the types of fire. Extinguishing agents. Fire fighting facilities.

Identification and classification of chemical agents. Labeling. Safety data sheets. Storage and handling.

To list types of personal protective equipment according to RD 773/1997.

To list types and effects of risks due to environmental conditions, chemical and biological agents. Exposure limits. Preventive

To explain the effects, measurement and prevention of physical agents: noise, vibrations, temperature, radiations and lighting. To explain the risks associated to lifting load tasks, repetitive movements, postures, working with a computer and psychosocial aspects.
