LEARNING OBJECTIVES OF THE SUBJECT

Upon completion of the course, students will be able to:

1. Historical Knowledge and Understanding

Understand the evolution of Western artistic production from prehistory to the 17th century, identifying the conceptual and practical transformations of each historical period.

Comprehend the fundamental differences between the premodern conception of artistic making and the modern notion of "fine arts" that emerged in the 18th century.

Contextualize artistic works within their original cultural, religious, and symbolic frameworks, moving away from purely contemporary aesthetic interpretations.

2. Critical Analysis and Interpretation

Analyze works of painting, sculpture, and architecture as manifestations of specific systems of thought, ritual practices, and social structures.

Interpret historical texts by philosophers and image producers to understand the theoretical reflections of each era on art and craftsmanship.

Relate artistic production to transformations in thought: from intuitive to rational man, from medieval mystical symbolism to the humanist return to classical tradition.

3. Research and Communication Skills

Develop original analytical work on a specific work, text, or period, applying art history research methodologies.

Actively participate in academic debates, grounding arguments through analysis of primary and secondary sources.

Communicate complex ideas clearly and in a structured manner, both orally and in writing, using discipline-specific vocabulary.

4. Direct Experience and Synthesis

Apply theoretical knowledge to direct analysis of works in museum contexts, developing critical observation skills. Synthesize and systematically organize course content, creating a personal dossier that reflects the learning process. Integrate experiences from visits and study trips with theoretical content covered in the classroom.
