#### PRIOR SKILLS

Students must know the basic concepts of survival analysis. These concepts include: Censored data, Likelihood in the presence of censoring, Continuous parametric distributions other than normal, Kaplan-Meier survival estimator, Log-rank test, Accelerated Failure Time Model, Cox proportional hazards model and Diagnostic of the Cox Regression model. The student can find these concepts in chapters 2-4, 7-8, 11-12 in the book "Survival analysis: techniques for censored and truncated data" by Klein and Moeschberger. These topics could have been self-learned, in the first semester Lifetime Data Analysis course or in other undergraduate or postgraduate courses.

## TEACHING METHODOLOGY

Lectures are organized into two types:

a) Theoretical sessions in which the teacher presents and discusses the general learning objectives and basic concepts. These concepts are motivated with real case studies. The support material used will be published in advance in Atenea (syllabus, content, slides, examples, scheduled assessment activities, references, ...)

Students will give a presentation of a topic related to the material of block 2.

b) Laboratory classes. These sessions focus on the practical aspects of the methodology. Software R is available for the students and they can continue laboratory sessions in their hours of self study.

Students must devote enough time to complement the lectures by reading research papers, solving problems, learning relevant software, etc.

## LEARNING OBJECTIVES OF THE SUBJECT

The course Advanced Survival Analysis prepares students to address situations in which the data presents complex patterns of censoring, where the covariates could vary over time, the multivariate analysis of two or more times to an event as well as competing risks and multistate models.
