### DEPARTMENT OF RESEARCH AND UNIVERSITIES

#### UNIVERSITARY AND RESEARCH ADMINISTRATION AGENCY

**RESOLUTION REU/2470/2023, of July 3, by which the regulatory bases of the adjustments to the international mobility of students with academic recognition are approved, the mobility of students within the framework of the Program of wealth and innovation in the training of masters of Catalan universities (MOBINT - MIF).**

The strategic grant plan of the Department of Research and Universities of the Generalitat de Catalunya for the period 2022-2025 will serve one of the departmental objectives to strengthen and modernize the Catalan university system, guaranteeing sound financing, fair access and the recruitment and retention of talent. One of the strategic objectives is to strengthen the efficiency and believe the Catalan public system grants for university students with the pending transfer and the increase in beneficiary of assets.

In line with the previous paragraphs and with the will to strengthen and modernize the Catalan university system and to focus the efforts to promote the international mobility of university students, these bases that regulate the adjustments to the international mobility of the university students are published. Student with academic recognition and student mobility within the framework of the Program for excellence and innovation in the training of Catalan universities.

Law 7/2001, of May 31 (DOGC no. 3407, of 6.12.2001), creates the Agency for Management of University and Research Adjustments (AGAUR) as a public right entity that adjusts its performance to the Private rights, with their own legal personality, full capacity to work and their own assets for the compliance of the six functions.

It is the responsibility of the AGAUR to execute programs of scholarships, loans, grants and other activities to promote university studies, scientific and technical research and technological innovation in Catalonia.

L'AGAUR is attached to the Department of Research and Universities, in accordance with the provisions of Decree 115/2022, of June 14, on the restructuring of the Department of Research and Universities. The provisions of Chapter

IX of Legislative Decree 3/2002, of December 24, are applicable, pursuant to which the Refós Text of the Law of Public Finances of Catalonia is approved, in relation to the legal regime of subsidies and transfers of the Generalitat of Catalonia; Law 38/2003, of November 17, general subsidies, and Royal Decree 887/2006, of July 21, for which the Regulation of Law 38/2003, of November 17, general subsidies, is approved. The Order REU/178/2022, of July 19, is applicable, which approves the obligatory electronic processing of the procedures for adjudications and subsidies

of public competition of the Agència de Gestió d'Ajuts Universitaris i de Research.

Article 11 of the AGAUR Statutes, approved by the Government of the Generalitat de Catalunya mitjançant Decree 168/2002, of June 11, provides that it corresponds to the Board of Directors to approve the calls for grants and subsidies, hereby resolved -them. These facultats have been delegated, as of April 28, 2022, to the president of the Executive Committee of University Aids (CEAU).

Article 1

Approve the regulatory bases of the ajuts to the international mobility of the students with academic recognition and the mobility of the students within the framework of the Program of excellence and innovation in the training of masters of the Catalan universities, according to the annex d'aquesta resolved.

The grants awarded by means of Resolution REU/2304/2022, of July 15, are still in force for the regulatory bases in relation to what they are going to grant.

## repealing provision

Resolution REU/2113/2022, of June 17, is repealed, for which the regulatory bases of the adjustments to the international mobility of students with academic recognition are approved, the mobility of students within the framework of the Program of Improvement and innovation in the training of masters of Catalan universities (MOBINT-MIF) (DOGC no. 8714, of 7.7.2022).

## final disposition

Against this resolution, which exhausts the administrative route, it is possible to file the following appeals: a legal appeal for reinstatement before the president of the CEAU, within a month to compute the indemnity of the seva publication at *Official Gazette of the Generalitat de Catalunya* (DOGC), in accordance with the provisions of articles 123 and 124 of Law 39/2015, of October 1, of the common administrative procedure of public administrations; or directly from an administrative contentious appeal before the administrative contentious judgments of Barcelona, in the term of two months, to report the same publication to the DOGC, in accordance with articles 8, 14 and 46 of the Law 29/1998, of July 13, regulating the administrative contentious jurisdiction.

## ANNEX

## I. General rules

## —1 Object

1.1 Grant grants to the students of the Catalan universities that have been selected for an academic state of physical mobility, in order to contribute to the financing of the expenses that study in other countries entails.

There are three adjustment modalities:

Modality A: academic stay with academic recognition, within the framework of the Erasmus+ Program and the following associated countries: the Regne Unit, Suïssa, the Faroe Islands, Andorra, Monaco, San Marino and the Vaticà City, dedicated to the students of the Catalan universities. This modality is reserved for the countries that participate in the program.

Modality B: academic stay with academic recognition to the rest of the countries of the world, within the framework of the international mobility programs, intended for students of Catalan universities.

Modality C: academic stay with academic recognition, within the framework of the Program for excellence and innovation in the training of masters of Catalan universities.

It should be noted that it is not possible to obtain the adjustment more than once when you start your studies.

1.2 Within the framework of bilateral relations in the Euroregion of the Pyrenees-Mediterranean region, it is planned to grant a complementary allowance to foster and promote the mobility of Catalan university students who are currently studying at universities in the region French d'Occitània. This adjustment consists of a single payment that will be automatically affected, if escau, to the other adjustments that the student may perceive in the framework of the mobility programs that provide for these regulatory bases (modality A) and provided that they complete the requirements that are hi foresee.

—2 beneficiary people

2.1 People who meet the following specific requirements may be beneficiaries:

a) Have Spanish citizenship or any other state member of the European Union. For the citizens of the European Union or their relatives, beneficiaries of the rights of free movement and residence, they must have the status of permanent residents or prove that the student or the people they support are self-employed workers. 'altri. For non-community students, the provisions of the regulations on rights and freedoms of strangers in Spain and their social integration apply. These requirements must be met by December 31, 2021. However, the citizens of the European Union have a valid residence permit at the time of formalizing the application.

b) Be enrolled or enrolled for any credit in a university of the Catalan university system, in the academic course that provides for the call and in any of the following studies:

For the modalities A and B: you are studying to obtain an official bachelor's degree or university master's degree from the Department of Research and Universities of the Generalitat de Catalunya, a situation that must be maintained during the transition period. The students can consult the student fence of the Canal Universitats in connection with the following:

For the modality C: you study undergraduate in Early Childhood Education and undergraduate in Primary Education, in all the offers, of all the universities of the university system of Catalonia that they teach and that are part of the Program of improvement and innovation in the training of mestres. This situation must be maintained for the duration of the adjustment.

c) For all the modalities, they must have passed a minimum of 60 credits at the time of presenting the application. Exceptionally, for the compulsory mobility programs of the Catalan universities specified by section VI of these regulatory bases, the data limit to meet and accredit this requirement is the one provided for in the call.

d) For all the modalities, have been selected or selected by a university of the Catalan university system for a stay within the framework of the international mobility programs of one of the three modalities that establish base 1.

e) For all the modalities, accredit a B2 level (entès com a B2.2 assolit) of one of the third languages established in the educational system of Catalonia (English, French, German or Italian), obtaining with a maximum in the final date of the term of presentation of sol·licituds. The levels of languages obtained after the completion of the submission of applications are not accepted in any case.

In the case that the language or languages of teaching in which the students are taught does not coincide with the one that the student has accredited, and among those that have been described in the previous paragraph, the student, moreover, has d 'accredit a B2 level of this language of teaching, except that the language of teaching followed one of the official ones of Catalonia.

In order to accredit one of the third established languages in the educational system of Catalonia, you must provide the certificates and the accredited diplomas that are recognized by Resolution EMC/122/2017, of 23 January, for which it is dona publicitat a l'Acord de la Board of the Interuniversity Council of Catalonia for the modification of the Agreement of April 24, 2015, on the recognition of certificates and accredited titles of competence in foreign languages <<http://portaldogc.gencat.cat/utillsEADOP/>>

In the case of other languages not included in this resolution, the B2 level must not be accredited by the certificates recognized by the Association of Language Centers in Higher Education (ACLES):

For languages not included in the CIC or ACLES Accord charts, the official certificates that complete the mateixos quality criteria are admitted.

It should be noted that the official language of l'Estat espanyol is not valued.

f) For the modalities A and B, have, at least, a average weighted grade of 5.7 of the file for the studies of the white knowledge of engineering and architecture, and of 6.30 for the Subtraction of the coneixement branches, calculated according to the criteria specified by base 8 of these regulatory bases.

For university master's degree studies, to calculate the overall mitjana grade it is also counted the mitjana grade of the undergraduate studies that have donat accés to the master's degree studies. If at the time of requesting the adjustment the mitjana note is not incorporated into the academic record of the master's studies, it will only be kept in count the mitjana note of the studies that have donated access to the university master's degree.

L'AGAUR may require the applicant to prove this point at any time of the procedure.

2.2 In addition, the beneficiary persons must meet the following general requirements:

- a) Be up to date with the tax obligations of the State and the Generalitat de Catalunya, and also of the obligations of the Social Security.
- b) Do not fall under the circumstances provided by article 13 of Law 38/2003, of November 17, general grants.
- c) Submit a statement on whether they have requested or obtained three public or private grants for the mateixa activity, in which the detailed relationship of the awarding entity and the amount so tendered or obtained must be recorded.
- d) Comply with the purpose of the subsidy due to the end of the subsidized activity in the terms determined by these bases.
- e) Donate compliance with the rules of conduct and the ethical principles of article 55.2 of Law 19/2014, of December 29, on transparency, access to public information and good governance and signature of adherence to the ethical code annex to l'Acord Gov/85/2016, of June 28. The acreditació d'aquests requisits s'ha de efectuar mitjançant the accrediting declaration or the corresponding responsible declaration, that cal incorporate to the request form.

2.3 Excluded from these regulatory bases:

- a) For the modalities A and B, non-university master's studies, postgraduate courses, university extension courses, doctorates and their own titles; Així mateix, in which they are excluded from the practices that do not have academic recognition.

With the mobility programs, the Erasmus Mundus programs (with finances) and internships or states fetish a cop finalitzats the studies and who do not have academic recognition are excluded.

- b) For modality C, students who have already had a previous university degree.
- c) Interchanges that do not involve physical mobility in other countries.

2.4 Només es pot gaudir de l'ajut un sol cop al llarg dels estudis universitaris.

2.5 Només es pot sol·licitar l'ajut per a modalitat.

2.6 The requirements that these regulatory bases provide, along with the corresponding call, must be

complir at the moment of sol·licitar l'ajut.

#### —3 Period

The academic mobility states must last until the end of the period established by the call.

#### —4 Quantity

4.1 With the purpose of collaborating in the financing of the mobility expenses, which implies the displacement and the state to other countries during the adjustment, it is granted to the students who meet the requirements of these regulatory bases and of the corresponding call that has obtained the minimum required score, according to the criteria of base 8, an amount of 200 euros (two-cents euros) per month for a maximum duration of the stay of six months; It is to dir, fins to a maximum of 1,200 euros (thousand two-cents euros) depending on the justifiable temps.

4.2 Per stay includes the period that elapses from the date of face-to-face admission to the university or the destination center until the date of face-to-face completion of this incorporation. Només es tenen en compte el dies de estada acadèmica per al computació de l'ajut. In the event that the duration is still shorter, by modifying the initial resolution of concession and the import granted it will be reduced depending on the effective period of stay. If in the end the duration is longer, the adjustment will not be increased.

4.3 In accordance with the one provided for in base 1.2 of these regulatory bases, a complementary allowance of 600 euros (six-cents euros) will be granted to students from Catalan universities who are currently studying at universities in the French region of 'Occitània and that continued to benefit from modality A of these regulatory bases and from the corresponding call. This complementary adjustment will be granted to the student who completes the requirements of these regulatory bases per strict order of academic punctuation and knowledge of the final language that is obtained by the credit press.

4.4 The grants are subject to the tax regime in force at the time of their granting.

#### —5 Sol·licituds and documentation

5.1 The request must be submitted by the interested party electronically through the "Tràmits" section of the Generalitat de Catalunya website (<http://web.gencat.cat/ca/tramits/>) following the instructions that s'hi foresee.

5.2 The use of the specific form is obligatory and, therefore, the non-compliment of this requirement with the consequence that the application is submitted but not submitted, according to article 66.6 of Law 39/ 2015, October 1.

5.3 Interested persons must sign the applications for telematic meetings and must authenticate themselves by the electronic signature systems that are accepted by the electronic office of the Generalitat de Catalunya for procedures of level and level, according to the criteria that establishes the Ordre VPD/93/2022, of April 28, for which the Catalog of identification systems and electronic signature is approved.

In the event that the applicants do not have electronic authentication mechanisms for the duration of any process, they can be identified and authenticated by the staff of the Administration of the Generalitat de Catalunya, who must carry out the process in nom seu utilitzant the electronic signature system that accredits with habilitated functionaries. With this purpose, the citizenry has to accredit and has to provide their express consent to be authenticated by the authorized personnel who go to the offices of face-to-face attention with functions of assistance in registration matters. The electronic office has a list of the public service offices that offer this service (<<https://web.gencat.cat/ca/contacte/oficines/#bloc2>>).

5.4 In the event of interruption due to accidental circumstances of the operation of the electronic system, and whenever technically possible, the user who accesses it must display a message on what this circumstance communicates, which must indicate the on-site records This is where you can present the documentation alternatively and report the effects of this interruption of the operation in the computer of the termini. However, when it is not technically possible for the user to agree to view the message, it is a matter of procedures that must be carried out obligatorily by telematics meetings, if an interruption occurs during the last day established for the realization of the corresponding procedure, this is may last a term during the three consecutive working days.

5.5 The applicants can present digitalized copies of the documents according to the one provided for in article 28 of Law 39/2015, of October 1, of the common administrative procedure of the administrations

public.

5.6 The normal application form is formatted by a general form and the following annexed documents, which must be attached to the form:

a) The credential or document issued by the university or the center of origin that certifies that the applicant has been selected for an academic mobility status with academic recognition for the course that the call provides for. In this certificate, I must state the following information: the university or the center of destination, the country of destination, the duration in months, the language of teaching in which the studies are taught at the university or the center of destination and if it is about an internship program. In case of discrepancies between the duration of the stay, the modality and the language of teaching requested by the interested person and the information that appears in the official documents issued by the university of origin, the information issued by the university or university shall prevail. the center of origin.

b) The complete academic record or the document, clearly stated by the center, in which it is easy to record the mitjana note of the academic record calculated according to the one established by these regulatory bases and the name of credits superats and matriculats fins al moment of sun request l'ajut.

Keeping in mind that the academic records may vary, from the moment in which the final adjustment is requested that the examination period ends, academic records will be accepted until the date of the end of the examination period.

Exceptionally, and for some cases of obligatory mobility programs, this circumstance is able to comply and accredit ends to the data that the call foresees.

c) To accredit the knowledge of languages, as a requirement or as a merit, you must provide the corresponding supporting documentation, according to the one indicated in base 2.1.e).

It is not in counting personal circumstances of knowledge of languages without a document that I accredited.

d) For the modalities A and B, the student of the university master's degree must provide a document, carefully certified by the center, in which it is easy to record the mitjana note of the academic record of the students who have donated accés, calculated according to the one established by these regulatory bases.

In the cases of the university master's degree studies that have not included the note in the academic record, at the time of submitting the application and the additional documentation, the note of the studies that have donated access to the university master's degree will be kept in count.

In the case of students who have studied at universities in other countries that they have not access to current studies at Catalan universities, in order to calculate the mitjana note of the files from the stranger, they must provide a document with the equivalence of the score from 0 to 10. This document can be obtained from the Ministerial website (<<https://www.educacionyfp.gob.es/servicios-al-ciudadano/catalogo/gestion/titulos/estudios-universitarios/titulos-extranjeros/equivalencia-average-grades.html>>).

This equivalence must be validated by the Catalan universities outside of lliurar-la together with the sol·licitud de l'ajut.

e) In case of having citizenship of any member state of the European Union and also in cases of non-community students, attach the corresponding residence document.

f) Qualsevol other documentation necessary to justify the academic or personal situation to the bequeathed by the applicant applicant.

5.7 L'AGAUR may require at any time of the processing of the adjustments the documentation that it considers necessary to accredit the concurrence of the requirements that these regulatory bases provide and the corresponding call. The non-provision of the documentation required in the legally foreseen terms may lead to the withdrawal of the sol·licitud.

Esmenes to the sol·licitud is able to present mitjançant the tràmit associated to an AGAUR file (provided documentation and other requests), to the "Tràmits" section of the website of the Generalitat de Catalunya (<<http://web.gencat.cat/ca/procedures/>>) or at any official electronic registry.

5.8 In general, the actions that require notification to the applicants are published in the electronic tauler of the Administration of the Generalitat de Catalunya (<<https://tauler.seu.cat/inici.do?idens=1>>) and, under informative title, on the AGAUR website. Especially in the event that the sol·licitud may not be considered, the person concerned must be notified of the publication in the electronic office of the Administration of the Generalitat of a diligence of the executive director or the executive director with the relationship of the documentation

basic and non-basic documentation that cal esmenar. The diligence must not indicate the motives and their reasons must be stated that, in case of not considering the sol·licitud for the basic documentation, in the term of 10 days to calculate the the publication of the diligence corresponding to the electronic tauler of the Administration of the Generalitat de Catalunya, it is understood that the applicants desist from their application, according to the one that disposes of article 68 of the Llei 39/2015 endorsed.

5.9 Keeping in mind that, in order to process the application, the AGAUR verifies the concurrence of different requirements, it is possible to publish various examination papers at different times of the processing of the applications.

5.10 The presentation of the application implies the full acceptance of these bases and the authorization to the AGAUR to obtain the certificates or verify the necessary data to process the adjustment, which are issued by other administrations or public entities, centers of Research, universities and, especially, the State Tax Administration Agency (AEAT) and/or any other administration, with the objective of satisfactorily resolving the call.

In case there are technical problems that impede or hinder the transfer of data, the necessary documents may be required from the applicant.

5.11 The inaccuracy, falsehood or omission of an essential nature of any given or document that accompanies the request leaves no sense in effecting this procedure, after giving hearing to the person concerned, entails the inadmissió of the request or the Revocation of the adjustment if this fet is connected after the concession resolution.

#### —6 Data of a personal nature

The data provided for the applicants will be incorporated into the AGAUR ownership contract system with the objective of managing and resolving the concession of the award, in accordance with the one that is exposed in these regulatory bases, and will be Agreements in a lawful, legal, transparent, adequate, pertinent, limited, exact and up-to-date manner, in compliance with the provisions of Regulation (EU) 2016/679 of the European Parliament and Organic Law 3/2018, of December 5 (LOPDGDD) . The legal basis for the data contract is the compliance of a legal obligation on the part of the person responsible for enforcing the consent of the interested party.

These data must be kept during the strictly necessary term to comply with the stated purpose, respecting in all cases the one that determines the regulatory bases of the call and the applicable filing regulations. L'AGAUR certifies that it has implemented the technical and organizational measures that comply with Regulation (UE) 2016/679 to guarantee the safety and integrity of the personal data included in the fitxers and to avoid alteration, loss i el tractament o l'accés no autoritzats.

L'AGAUR has to communicate the details of the applicants to the Department of Research and Universities so that it can exercise its own power to control the management of l'AGAUR as an entity attached to this department. It is also possible to produce communications of certain data to third public or private entities, continue because the intervention of these entities in the course of the adjustment management process could be necessary because it is correctly resolved, continue because it is provided for in some norm amb rang de llei.

As long as the interested party does not communicate the contrary, they understand that the six facts have not been modified and that they commit to notify the AGAUR of any variation.

In case of disagreement with the data contract, the applicants also have the right to file a claim before the Catalan Data Protection Authority.

#### —7 Termini of presentation of the applications

The term of presentation of the applications is fixed to the corresponding call.

#### —8 Rating

The granting of the grants is processed under a competitive bidding regime, in accordance with the valuation criteria determined by these bases and the corresponding call.



Even though it is tract of a procedure of competitive concurrence, thousands of the sol-licitud are not admitted a cop transcorregut the term of presentation of sol-licituds, carry out the cases provided for in these regulatory bases.

The evaluation is carried out exclusively on the information provided in the form and in the corresponding annexes.

8.1 The applications are valued according to the criteria and the following scores:

8.1.1 For modalities A and B:

a) Academic criteria (80/100): it is valued according to the apartment III of this annex. The mitjana note of the file is calculated from the global qualification scale of the titled person, from 0 to 10, according to the one provided by Royal Decree 1125/2003, of September 5, for which 'It establishes the European system of credits and the system of qualifications in official university degrees and is valid throughout the national territory, and is weighted by knowledge gaps.

Global qualification scale:

0-4.9: failed.

5.0-6.9: pass.

7.0-8.9: remarkable.

9.0-10: excel lent.

The credits obtained for academic recognition corresponding to formative activities not integrated into the study plan are not qualified numerically or computed for the purpose of the mitjana of the academic record.

b) Knowledge of languages (20/100): it is valued at levels C1 and C2 of knowledge of the language or the languages required as a requisite.

Exceptionally, level B2 or higher is also valued if the student provides proof of knowledge of a different language than the one already accredited as a requirement according to base 2.1.e).

The merits provided for in these regulatory bases, as well as in the corresponding call, must be accredited at the time of applying for the adjut.

—9 Selected

9.1 The selection of candidatures is made by a Selection Committee, which meets the criteria that establish base 8 of the regulatory bases, the call and the press availability.

Based on the above criteria, the commission sets the minimum height score for accessing each of the modalities of adjustments.

9.2 The commission can propose a reserve list, carefully prioritized, formed by the applications that have not been selected.
