RESOLUTION REU/2626/2023, of July 13, opening the call for mobility grants

international studentship with academic recognition and student mobility within the framework of

Improvement and innovation program in the training of teachers at Catalan universities for the current year academic year 2023-2024 (MOBINT – MIF) (ref. BDNS 708450).

Law 7/2001, of 31 May (DOGC no. 3407, of 12.6.2001), creates the University Grants Management Agency and Research (AGAUR) as a public law entity that adjusts its actions to private law, with personality own legal status, full capacity to work and own assets for the fulfillment of its functions.

The AGAUR is responsible for the execution of the programs of grants, loans, subsidies and other activities of promotion of university studies, scientific and technical research and technological innovation in Catalonia.

The AGAUR is attached to the Department of Research and Universities, in accordance with the provisions of the Decree 115/2022, of June 14, restructuring the Department of Research and Universities. The provisions of

chapter ix of Legislative Decree 3/2002, of December 24, which approves the Revised text of the Public Finances Act of Catalonia, in relation to the legal regime of subsidies and transfers from the Generalitat de Catalunya; Law 38/2003, of November 17, general subsidies, and the Royal Decree 887/2006, of July 21, approving the Regulations of Law 38/2003, of November 17, general subsidies.

Article 11 of the Statutes of the AGAUR, approved by the Government of the Generalitat of Catalonia by means of the Decree 168/2002, of June 11, provides that it is up to the Board of Directors to approve calls for scholarships and subsidies, as well as how to solve them. These powers have been delegated, on April 28, 2022, in the president of the Executive Commission for University Grants (CEAU).

On July 7, 2023, Resolution REU/2470/2023, of July 3, was published, approving the regulatory bases for aid to the international mobility of students with academic recognition and the student mobility within the framework of the Improvement and Innovation Program in teacher training Catalan universities (MOBINT – MIF).

For all this,

Solution:

Article 1

Open the call for grants for international student mobility with recognition academic and student mobility within the framework of the Program for improvement and innovation in the training of teachers from Catalan universities for the 2023-2024 academic year (MOBINT - MIF).

Article 2

2.1 This call is funded by the General Directorate of Universities and the Interuniversity Council of Catalonia of the Department of Research and Universities. The overall amount is 2,720,000.00 euros (two million seven hundred and twenty thousand euros), which are charged to item 480.0001 of the AGAUR budget for the year 2023. Of this amount, the General Directorate of Universities allocates 2,700,000.00 euros (two million seven hundred thousand euros) and the Interuniversity Council of Catalonia allocates 20,000.00 euros (twenty thousand euros).

Of the total amount of the call, 1,900,000.00 euros (one million nine hundred thousand euros) are allocated to the

modality A, 600,000.00 euros (six hundred thousand euros) to modality B, 200,000.00 euros (two hundred thousand euros) to modality C and 20,000.00 euros (twenty thousand euros) to the complementary aid in the scope of the Euroregion. In case if any of the funds established for a modality are not used up, the corresponding amount can be awarded to another modality, as long as the minimum required score is respected, in accordance with the criteria of evaluation.

2.2 The granting of aid is conditional on the existence of adequate and sufficient credit at the time of the concession resolution.

2.3 This maximum allocation can be extended by a percentage of up to 20% before resolution awarding of grants, without the need to publish a new call.

2.4 The grant may be reduced in whole or in part before the final resolution is issued, a consequence of the restrictions that derive from the fulfillment of the objectives of budgetary stability and financial sustainability.

2.5 Once this call has been resolved, in the event that the maximum amount set by this article 2 has not been exhausted, or in the event that there are residuals arising from the resignations or revocations of the grants granted, they will be able to assign new awards to the applications estimated finally, as a result of the interposition of one administrative appeal or administrative dispute, or to the denied requests that have remained on the list of priority reservation, as long as they have reached the necessary technical qualification and that the actions are possible carry out within the terms established by the regulatory bases and this call.

Article 3

The grants provided for in this call are governed by:

- a) Resolution REU/2470/2023, of July 3, which approves the regulatory bases for aid to international student mobility with academic recognition and student mobility within the framework of the Program for improvement and innovation in the training of teachers of Catalan universities (MOBINT- MIF).
- b) The provisions on subsidies in Chapter IX of the revised text of the Public Finance Law of Catalonia, approved by Legislative Decree 3/2002, of 24 December, as well as the basic regulations on the matter of subsidies and the rest of the applicable regulations.

Article 4

4.1 The deadline for submission of applications begins the day after the publication of this call at the DOGC, and ends on September 15 at 2:00 p.m., Barcelona local time, on the last day of the deadline.

4.2 Applications can be submitted in accordance with the provisions of base 5 of Resolution REU/2470/2023, of July 3, by which the regulatory bases for aid to international student mobility are approved with academic recognition and student mobility within the framework of the Improvement and Innovation Program in the training of teachers from Catalan universities (MOBINT - MIF).

Article 5

People applying for the aid must have registered at a university in the system Catalan university in studies leading to an official degree during the 2022-2023 and 2023-2024 academic years.

Article 6

The people applying for the aid must have been selected for an international mobility stay face-to-face with academic recognition for the 2023-2024 academic year.

Article 7

The period for the academic stay must be between the month of June 2023 and the month of October 2024.

Article 8

The credential or document issued by the university or center of origin must state that the stay academic will take place during the 2023-2024 academic year and will have academic recognition. There are also state the center of destination, the country of stay, the language of instruction at the university or the center of destination and length of stay in months.

Article 9

The incorporation document must be submitted no later than August 31, 2024.

Article 10

The supporting document must be submitted no later than October 31, 2024.

Article 11

The academic record of the mandatory mobility stays can be submitted until September 30, 2024 or, if later, the last day of the due date for the submission of amendments.

Article 12

12.1 The competent body for the organization and instruction of this call is the person holding the executive direction of the AGAUR.

12.2 The resolution of the call corresponds to the Board of Directors of the AGAUR and, by delegation, to the CEAU or the person who holds the presidency, according to the Agreement of the Board of Directors, of April 28, 2022 (Resolution REU/1421/2022, of May 10, DOGC no. 8668, of 16.5.2022).

12.3 The procedure for awarding this subsidy is competitive.

12.4 The maximum legal term to resolve this call is six months, counting from its publication in the *Official Journal of the Generalitat of Catalonia* (DOGC). Once this period has passed without express resolution, the requested aid will be understood as rejected due to administrative silence.

12.5 The grant award decision will be notified through its publication on the electronic board of the Administration of the Generalitat of Catalonia. In order to spread it more, and for informative purposes, the result of the resolution can be consulted on the AGAUR website.

12.6 Against the concession resolution, which exhausts the administrative route, the interested parties can file, as an option, an appeal for reinstatement before the president of the CEAU, in the period of one month from the day after its publication on the electronic board of the Generalitat de Catalunya, or or they can directly file an administrative contentious appeal before the administrative contentious court of Barcelona, within two months from the day after its publication, in accordance with what provide for articles 123 and 124 of Law 39/2015, of October 1, on the common administrative procedure of public administrations, and articles 8, 14 and 46 of Law 29/1998, of July 13, regulating the administrative contentious jurisdiction.

Article 13

Against this resolution, which exhausts the administrative route, the interested parties can file, with discretionary nature, an appeal for replacement before the president of the CEAU, within a month from the day after its publication in the DOGC, or they can file an appeal directly administrative dispute before the administrative dispute court of Barcelona, within two months a count from the day after its publication, in accordance with the provisions of articles 123 and 124 of the Law 39/2015 mentioned, and articles 8, 14 and 46 of the aforementioned Law 29/1998.
