UNIVERSITY AND RESEARCH AID MANAGEMENT AGENCY

RESOLUTION REU/2304/2022, of July 15, opening the call for grants for international student mobility with academic recognition and for student mobility within the framework of the Improvement and Innovation Program in the training of teachers of Catalan universities for the academic year 2022-2023 (MOBINT – MIF) (ref. BDNS 639684).

Law 7/2001, of 31 May (DOGC no. 3407, of 12.6.2001), creates the Agencia de Gestión d'Ajuts Universitaris y de Recerca (AGAUR) as a public law entity that adjusts its performance to private law, with its own legal personality, full capacity to act and its own assets for the performance of its functions.

The AGAUR is responsible for the execution of programs of grants, loans, subsidies and other activities to promote university studies, scientific and technical research and technological innovation in Catalonia.

The AGAUR is attached to the Department of Research and Universities, in accordance with the provisions of Decree 115/2022, of 14 June, restructuring the Department of Research and Universities. The provisions of chapter ix of Legislative Decree 3/2002,

of 24 December, which approves the revised text of the Public Finances Act of Catalonia, in relation to the legal regime of subsidies and transfers of the Generalitat of Catalonia; Law 38/2003, of November 17, general subsidies, and Royal Decree 887/2006, of July 21, which approves the Regulations of Law 38/2003, of November 17, general subsidies .

Article 11 of the Statutes of the AGAUR, approved by the Government of the Generalitat of Catalonia through Decree 168/2002, of 11 June, states that it is the responsibility of the Board of Directors to approve calls for grants and subsidies, as well as to resolve - them These powers have been delegated, on April 28, 2022, to the president of the Executive Commission for University Grants (CEAU).

On July 7, 2022, Resolution REU/2113/2022, of June 17, was published, approving the regulatory bases for grants for international student mobility with academic recognition and for the mobility of the student body within the framework of the Program for improvement and innovation in the training of teachers of Catalan universities (MOBINT - MIF).

For all this,

Solution:

Article 1

Open the call for grants for international student mobility with academic recognition and student mobility within the framework of the Improvement and Innovation Program in the training of teachers at Catalan universities for the academic year 2022-2023 (MOBINT - MIF).

Article 2

2.1 This call is funded by the Directorate General of Universities and the Interuniversity Council of Catalonia of the Department of Research and Universities. The overall amount is 2,720,000.00 (two million seven hundred and twenty thousand) euros, which is charged to item 480,0001 of the AGAUR budget for the year 2022.

Of this amount, the Directorate General of Universities allocates 2,700,000.00 (two million seven hundred thousand) euros and the Interuniversity Council of Catalonia allocates 20,000.00 (twenty thousand) euros.

Of the total amount of the call, 1,900,000.00 (one million nine hundred thousand) euros are allocated to modality A,

600,000.00 (six hundred thousand) euros in modality B, 200,000.00 (two hundred thousand) euros in modality C and 20,000.00 (twenty thousand two hundred) euros in complementary aid in the field of the Euroregion. In the event that any of the allocations established for a modality are not used up, the corresponding amount can be awarded to another modality, as long as the minimum required score is respected, in accordance with the assessment criteria.

2.2 The granting of aid is conditioned on the existence of adequate and sufficient credit at the time of the granting decision.

2.3 This maximum amount can be increased by a percentage of up to 20% before the decision to award the aid, without the need to publish a new call.

2.4 The grant may be reduced in whole or in part before the final resolution is issued, as a result of the restrictions that arise from meeting the objectives of budgetary stability and financial sustainability.

2.5 Once this call has been resolved, in the event that the maximum amount set in this article 2 has not been exhausted, or in the event that residuals are generated from the resignations or revocations of the grants granted, new awards may be assigned to the requests finally estimated, as a result of the filing of an administrative appeal or administrative dispute, or to the denied requests that have remained on the prioritized reserve list, as long as they have reached the necessary technical qualification and that the actions can be carried out within the terms established by the regulatory bases and this call.

Article 3

3.1 The deadline for submission of applications is one month from the day after the publication of this call in the DOGC, and ends on September 15, 2022 at 2:00 p.m., Barcelona local time, of the last day of the term.

3.2 Applications can be submitted in accordance with the provisions of base 5 of Resolution REU/2113/2022, of June 17, which approves the regulatory bases for aid to the international mobility of studentship with academic recognition and student mobility within the framework of the Program for improvement and innovation in the training of teachers in Catalan universities (MOBINT - MIF).

Article 4

Applicants for the aid must have registered in a university of the Catalan university system in studies leading to an official qualification during the 2021-2022 and 2022-2023 academic years.

Article 5

The people applying for the aid must have been selected for an in-person international mobility stay with academic recognition for the 2022-2023 academic year.

Article 6

The period for the academic stay must be between June 2022 and October 2023.

Article 7

In the credential or document issued by the university or center of origin, it must be stated that the academic stay will take place during the 2022-2023 academic year and that it will have academic recognition. The center of destination, the country of the stay, the language of instruction at the university or center of destination and the duration of the stay in months must also be stated.

Article 8

The incorporation document must be submitted by August 31, 2023 at the latest.

Article 9

The supporting document must be submitted no later than October 31, 2023.

Article 10

The grants provided for in this call are governed by:

a) Resolution REU/2113/2022, of June 17, which approves the regulatory bases for aid to the international mobility of students with academic recognition and student mobility within the framework of the Program of improvement and innovation in the training of teachers in Catalan universities (MOBINT- MIF).

b) The general regulation of subsidies.

Article 11

11.1 The competent body for the organization and instruction of this call is the person in charge of the executive management of the AGAUR.

11.2 The resolution of the call corresponds to the Board of Directors of the AGAUR and, by delegation, to the CEAU or the person who holds the presidency, according to the Agreement of the Board of Directors, of April 28, 2022 (resolution REU/1421/2022, of May 10, DOGC no. 8668, of 16.5.2022).

11.3 The procedure for awarding this grant is competitive.

11.4 The maximum legal term to resolve this call is six months, counting from the publication in the *Official Journal of the Generalitat of Catalonia* (DOGC). Once this period has passed without an express resolution, the requested aid will be considered rejected due to administrative silence.

11.5 The decision to award grants will be notified through its publication on the electronic board of the Administration of the Generalitat de Catalunya. In order to spread it further, and for informational purposes, the result of the resolution can be consulted on the AGAUR website.

11.6 Against the concession decision, which exhausts the administrative process, the interested parties may file, with discretion, an appeal for reinstatement before the president of the CEAU, within a period of one month from the day after the its publication on the electronic board of the Generalitat of Catalonia, or they can directly file an administrative contentious appeal before the administrative contentious court of Barcelona, within two months from the day after its publication, in accordance with what provide for articles 123 and 124 of Law 39/2015, of October 1, on the common administrative procedure of public administrations, and articles 8, 14 and 46 of Law 29/1998, of July 13, regulating of the administrative contentious jurisdiction.

Article 12

Against this resolution, which exhausts the administrative route, the interested parties can file, with discretion, an appeal for replacement before the president of the CEAU, within one month from the day after its publication to the DOGC, or they can directly file an administrative contentious appeal before the administrative contentious court of Barcelona, within two months from the day after its publication, in accordance with the provisions of articles 123 and 124 of the Law 39/2015 mentioned, and articles 8, 14 and 46 of Law 29/1998 mentioned.
